(1) Research fields of design and fabrication of integrated photonic devices in the field of optical waveguides, photonic crystals, Si photonics etc.

(2) Research fields of application measurement using terahertz wave or optical frequency comb.

(4) Those who can be actively involved in industry-academia collaboration, domestic and international collaboration, and regional contribution, and also work on institute manifestation and globalization, along with acquisition of external research funds such as Grants-in-aid for Scientific Research and acquisition of intellectual property.
